Defendant's motion to dismiss Plaintiff's Complaint; for judicial notice of certain pleadings; and Plaintiff's motion for a restraining order came on for hearing on April 3, 2015. Plaintiff appeared in person and through his attorney, Gary Montanna, and Defendant's appeared in person and through their attorney, Steven Sandven.
