1 I, CHERRI BRICK, declare:

2 1. I have personal knowledge of the facts stated herein and would competently
3 testify thereto under oath if called as a witness.


4 2. At all times referred to herein, I have been the assistant to Joop Bollen, the
5 Director of the South Dakota International Business Institute (SDIBI). I receive and open
6 correspondence addressed to Mr. Bollen and meet persons entering the SDIBI's offices.

7 3. I have reviewed a proof of service that was filed in the above-captioned action on
8 September 30, 2008. It appears as Page 2 of 3 on Document 13 of the Court's electronically-
9 filed documents. The document contains two typewritten misspellings of my name as "Cherry"
10 Brick and even contains a signature that appears to misspell my first name. The signature is not
11 mine. I never saw or signed this document, nor did I ever serve the documents referenced
12 therein. I did not authorize any person to sign this document in my name.

13 4. I recall that, in August 2008, a Brown County Deputy Sheriff was looking for Mr.
14 Bollen. I do not recall signing anything. I was not informed that it involved a lawsuit, or that I
15 was being served. I do not recall ever seeing a document entitled "Summons" in relation to Mr.
16 Bollen's work with Hanul Professional Law Corporation or Darley International, LLC. I have
17 never been authorized by Mr. Bollen or any other person to accept service of legal process on
18 behalf of the SDIBI, Northern State University, the South Dakota Board of Regents, or the State
19 of South Dakota.

20 5. Although I work for the SDIBI, my paychecks are issued on the account of the
21 State of South Dakota.

22 I declare under penalty of perjury of the laws of the United States of America that the
