The undersigned, being duly sworn upon oath charges that, in the CountY of Brown, State of South Dakota, Joop Bollen did commit the public offenses of:

## Count 1

That on or about the 2nd day of February, 2012, in the County of Brown, State of South Dakota, Joop Bollen did commit the public offense of Unauthorized Disposal of Personal Property Subject to Security Interest (SDCL 44-1-12), in that Joop Bollen did willfully destroy, conceal, sell, or in any manner dispose of or materially injure any part of the property covered by such mortgage, conditional sales agreement, or security agreement without the written consent of the holder of such mortgage, conditional sales agreement, or security agreement to-wit: Joop Bollen disposed of \$300,000 from Indemnification Fund 2 not in accordance with the security agreement executed with the South Dakota Department of Tourism and State Development, and failing to notify the holder of the security agreement and not in accordance with the usual and customary use of the property while the

security agreement remained in force contrary to statute in such case made and provided against the peace and dignity of the State of South Dakota.

#### Count 2

That on or about the 30th day of April, 2012, in the County of Brown, State of South Dakota, Joop Bollen did commit the public offense of Unauthorized Disposal of Personal Property Subject to Security Interest (SDCL 44-1-12), in that Joop Bollen did willfully destroy, conceal, sell, or in any manner dispose of or materially injure any part of the property covered by such mortgage, conditional sales agreement, or security agreement without the written consent of the holder of such mortgage, conditional sales agreement, or security agreement to-wit: Joop Bollen disposed of \$370,000 from Indemnification Fund 2 not in accordance with the security agreement executed with the South Dakota Department of Tourism and State Development, and failing to notify the holder of the security agreement and not in accordance with the usual and customary use of the property while the security agreement remained in force contrary to statute in such case made and provided against the peace and dignity of the State of South Dakota.

#### Count 3

That on or about the 30th day of April, 2012, in the County of Brown,

State of South Dakota, Joop Bollen did commit the public offense of

Unauthorized Disposal of Personal Property Subject to Security Interest (SDCL

44-1-12), in that Joop Bollen did willfully destroy, conceal, sell, or in any

manner dispose of or materially injure any part of the property covered by such

mortgage, conditional sales agreement, or security agreement without the written consent of the holder of such mortgage, conditional sales agreement, or security agreement to-wit: Joop Bollen disposed of \$96,838.74 from Indemnification Fund 2 not in accordance with the security agreement executed with the South Dakota Department of Tourism and State Development, and failing to notify the holder of the security agreement and not in accordance with the usual and customary use of the property while the security agreement remained in force contrary to statute in such case made and provided against the peace and dignity of the State of South Dakota.

#### Count 4

That on or about the 7th day of May, 2012, in the County of Brown,
State of South Dakota, Joop Bollen did commit the public offense of
Unauthorized Disposal of Personal Property Subject to Security Interest (SDCL
44-1-12), in that Joop Bollen did willfully destroy, conceal, sell, or in any
manner dispose of or materially injure any part of the property covered by such
mortgage, conditional sales agreement, or security agreement without the
written consent of the holder of such mortgage, conditional sales agreement, or
security agreement to-wit: Joop Bollen disposed of \$166,606.89 from
Indemnification Fund 2 not in accordance with the security agreement
executed with the South Dakota Department of Tourism and State
Development, and failing to notify the holder of the security agreement and not
in accordance with the usual and customary use of the property while the

security agreement remained in force contrary to statute in such case made and provided against the peace and dignity of the State of South Dakota.

### Count 5

That on or about the 19th day of June, 2012, in the County of Brown, State of South Dakota, Joop Bollen did commit the public offense of Unauthorized Disposal of Personal Property Subject to Security Interest (SDCL 44-1-12), in that Joop Bollen did willfully destroy, conceal, sell, or in any manner dispose of or materially injure any part of the property covered by such mortgage, conditional sales agreement, or security agreement without the written consent of the holder of such mortgage, conditional sales agreement, or security agreement to-wit: Joop Bollen disposed of \$310,000 from Indemnification Fund 2 not in accordance with the security agreement executed with the South Dakota Department of Tourism and State Development, and failing to notify the holder of the security agreement and not in accordance with the usual and customary use of the property while the security agreement remained in force contrary to statute in such case made and provided against the peace and dignity of the State of South Dakota. contrary to the statute in such case made and provided against the peace and dignity of the State of South Dakota.
